1. Valid Score Card of CET / CAT / MAT / XAT / ATMA / CMAT.
2. Statement of Marks of HSC and SSC.
3. Statement of Marks and Certificate for the Bachelor's Degree Examination. Candidate who has appeared for final year degree examination has to submit the Marksheet of semester I to V or VII. Final Year Marksheet on or before **10th August, 2018**.
4. Birth Certificate.
5. Nationality Certificate (The School Leaving Certificate / Birth Certificate indicating the Nationality of the candidate as 'Indian'. Indian Passport in the name of the candidate, issued by appropriate authorities.
6. Work Experience Certificates, if any.
7. Gap Certificate if graduated before March / April / May 2018.
8. Undertaking from the student and parent as per the format provided by the institute (if not submitted).

Action against ragging

Maharashtra Prohibition of Ragging Act 1999 and prevention and prohibition of Ragging (Appendix 12 published in AICTE Approval Process Handbook 2011-12) and their amendments which may be published from time to time. The Act is in effect from 15th May, 1999 has the following provisions for Action against Ragging.

- a) Ragging within or outside of educational Institution is prohibited.
- b) Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside any educational Institution shall, on conviction, be punished with imprisonment for a term up to 2 years and / or penalty, which may extend to ten thousand rupees.
- c) Any student convicted of an offence of ragging shall be dismissed from the educational Institution and such student shall not be admitted in any other educational Institution for a period of five years from the date of order of such dismissal.
- d) Whenever any student or, as the case may be, the parent or guardian or a teacher of an educational Institution complains, in writing, or ragging to the head of the educational Institution, the head of the educational Institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately forward the complaint to the police station having jurisdiction over the area in which the educational Institution is situated, for further action. Where, on enquiry by the head of the educational Institution, it is found that prima facie there is no substance, in the complaint received, he / she shall intimate the fact, in writing, to the complainant. The decision of the head of the educational institution shall be final.

- e) If the Head of the educational Institution fails or neglects to act in the manner specified in section "d" above when a complaint of ragging is made, such person shall be deemed to have abetted the offence and shall, on conviction, be punished as provided for in section "b" above.
- f) Undertaking from the candidate shall be taken while admitting the candidate in the Institute.

Any Acts or its amendments which may be published from time to time by AICTE, Government or judgments by Hon. Supreme Court of India, Hon. High Court of Mumbai etc. will be applicable to Candidates and Institutions covered under these rules of admission.
